

## Promotion Rules

### Black Friday Shopping Event – November 2022

1. **Black Friday Shopping Event** will take place on Friday, November 25, 2022. Redemption period is from 10:00am - 10:00pm. Earning period is from 12:01am - 9:30pm.
2. Participants must be 18 years or older and a Morongo Rewards member to participate. Morongo Rewards membership is fast, free, and easy. Register for a Morongo Rewards membership at the Morongo Rewards Desk, or at the Promotions counter
3. Each eligible Morongo Rewards member playing Slots or Video Poker will receive one (1) \$25 Gift Voucher after earning 500 points between 12:01am and 9:30pm. Each eligible Table Games player (excluding MCRS “live” Poker) will earn one (1) \$25 Gift Voucher for \$35 in average theoretical loss.
4. Gift voucher earned for 500points must be redeemed at Morongo Casino Resort & Spa
5. After earning the 500points, Morongo Rewards members can swipe a maximum of four (4) times.
6. Morongo Rewards members can pay using their incentive cash balance, cash, or credit.
