

Beach Bowling Rules – August 2022

Promotion Rules

1. The Beach Bowling takes place every Wednesday and Thursday in August beginning Wednesday, August 3 – Thursday August 31, 2022. All Morongo Rewards Members at Casino Morongo are eligible to participate in the promotion. Morongo Rewards and membership is fast, free and easy. MCRS “Live” Poker, MCRS Machines, Travel Center machines, and Canyon Lanes machines do not qualify for the promotion.
2. Contestants must be 18 years or older and a Morongo Rewards member to participate. Morongo Rewards membership is fast, free, and easy.
3. The Beach Bowling will be located at the Promotional Stage. Two (2) Morongo Rewards members will be randomly drawn every thirty minutes on Wednesdays and Thursdays from 12:00pm – 6:00pm. Guests must earn 10 points in the previous hour to qualify:
 - a. Entries must be activated at least one hour prior to each drawing
 - b. Entries do not roll over and will expire after each daily promotion.
 - c. Guests must have an active open rating at the time of the drawing to be eligible to win.
 - d. Drawings will continue until all two (2) winners have been identified.
 - e. Guest’s name will be announced on the casino microphone and will have two (2) minutes to claim their prize at the Promotional Stage near the bar.
 - f. If a guest does not claim their prize within the time allotted, a new name will be drawn.
 - g. Guests must have a valid photo ID and Morongo Rewards card to be eligible to win. This process will continue until both winners have been located and identified.
4. Guests may win more than once per day.
5. The participants will get a chance to bowl and knock over pins in our Beach Bowling Giveaway. Guests will check in at the promotion stage and bowl in order of arrival.
6. Each contestant will bowl one time, the guest who knocks over the most pins will win \$200 Free Slot Play (FSP), the runner up wins \$25 FSP.
7. In the event of a tie, guests will bowl another frame to determine the winner. If that results in a tie, both participants will split the prize and receive \$125 FSP.
8. The participant that arrives will get to bowl first.
9. FSP will be loaded to winners’ accounts within thirty (30) minutes and will expire at 11:59pm on the seventh day following the date on which the FSP is loaded.
10. Any unused FSP will be forfeited. Guests may win more than once per promotional day.
11. No cigarettes, cigars, matches, gum, food, beverages, etc. will be allowed at the ‘**Beach Bowling**’ gaming area during the game.
12. Management will not accept any private arrangements between players. No substitute players will be allowed.
13. All disputes must be handled at the promotion before the players leave the ‘**Beach Bowling**’ gaming area. In the event of a dispute, Management’s decision shall be final.
14. Participation in this promotion constitutes the player’s agreement to abide by the Official Rules and the decisions of Management.
15. Casino Morongo may require winners to complete and return a Liability Release and a Publicity Release as a condition of accepting any prize package. By participating in the **Beach Bowling**, contestants are deemed to have consented to the use of their image and likeness in any and all media, whether now known or hereafter devised, at any time.
16. Morongo’s staff, vendors, and entertainers, as well as guests who are currently expelled from MCRS or Casino Morongo, are not eligible to participate in the **Beach Bowling**.

17. Management, in its sole discretion, reserves the right to modify or terminate this promotion at any time with or without notice. All rulings made by Management during the promotion are final.
18. Any contestant found to be abusing the Official Rules or tampering with the promotion in any way may be disqualified and declared ineligible for any prize.
19. Offer is subject to all Federal and Tribal laws and regulations.
20. Management decisions concerning the administration of the **Beach Bowling** must be appealed in writing within three (3) days of the occurrence to Marketing Management at 49500 Seminole Drive, Cabazon, CA 92230. If the decision remains unresolved to the guest's satisfaction, it can be appealed in writing within fifteen (15) days of the occurrence to Morongo Gaming Agency at 49500 Seminole Drive, Cabazon, CA 92230. Morongo Gaming Agency's ruling is final and will have sixty (60) days to investigate and respond in writing. Management decisions concerning the administration of the **Beach Bowling** must be appealed within seven (7) days in writing to the Morongo Gaming Agency at 49500 Seminole Drive, Cabazon, CA 92230.
