

## **Ford F-150 Lightning Giveaway**

1. Participants must be 18 years of age or older and a Morongo Rewards member to participate. No purchase necessary. Morongo Rewards membership is fast, free and easy. 2. MCRS poker, MCRS Slot machines, Travel Center machines, and Casino Morongo machines do not qualify for the promotion.
3. **Morongo's Ford F-150 Lightning Giveaway** will begin on Saturday, June 1, 2024 and will continue until Wednesday, July 3, 2024.
