

Good Times Summer Slot Tournament Series

Promotion Rules

1. The Good Times Summer Slot Tournament Series is for qualified Morongo Rewards members only and is non-transferable.
2. Morongo Rewards members must earn 500 points on their Morongo Rewards cards to participate in the Good Times Slot Series Tournament.
3. From 10:00am – 10:00pm Wednesdays & Thursdays in August, August 3, 4, 10, 11, 17, 18, 24 & 25, 2022, taking place in the Tournament Zone (Zone 16) from 10:00am – 10:00pm.
4. Morongo Rewards members must swipe their Morongo Rewards card at any Morongo Rewards kiosk to receive their ticket entry, then head over to the tournament zone located near the Promotions stage to check in and play in the two-minute session.
5. Guests may participate up to 3 times per promotional day.
6. All guests who participate in the Good Times Slot Series Tournament will receive a \$25 FSP prize upon playing a two-minute session.
7. The top session winners of each day will receive \$50 gas vouchers, and the top 100 scores for each day will receive a prize from \$25 Free Slot Play to \$750 cash. Additionally, the top score of each week will receive \$1000 Free Slot Play (FSP).
8. The top one hundred (100) overall scores of Morongo's Good Times Slot Series will receive prizes ranging from \$75 FSP to \$10,000 cash! Guests who score within the top 100 for the month may qualify for a "prize multiplier" according to the *Prize Chart*.
9. Winners will be posted at www.morongocasinoresort.com/GoodTimesSlotSeries and all FSP will be loaded by 12:00pm on Saturday, August 6, 13, 20, & 27, 2022.
10. All FSP will expire within seven (7) days after that week's slot tournament. Cash winners will have seven (7) days to claim their prize at the Morongo Rewards counter.
11. Upon receiving a WDPF, guests then take the prize to the Main Cage cashier and present their Morongo Rewards card and matching valid photo ID to redeem.
12. Players must be in their assigned seat. Any players who exchange times or seats without the approval of Morongo Casino, Resort & Spa ("MCRS") Management may be disqualified.
13. No make-up sessions will be permitted. No exceptions.
14. No cigarettes, cigars, matches, gum, food, beverages, etc. will be allowed at the slot machine during tournament play.
15. In the event of a machine malfunction during tournament play, arrangements will be made to place the participant in another session, and the higher of the two scores will be used for that Round scoring.
16. In the event of a tie, the player's second highest score will be used to determine the Grand Prize Winner and the higher of the two scores will receive the superior final ranking.
17. MCRS Management will not accept any private arrangements between tournament players. No substitute players will be allowed.
18. All disputes must be handled at the machine before the players leave the Tournament Zone. In the event of a dispute, the MCRS Management's decision will be final.
19. Participation in this Tournament constitutes the player's agreement to abide by the official rules and the decisions of the MCRS Management.
20. MCRS may require winners to complete and return a Liability Release and a Publicity Release as a condition of accepting any prize package. By participating in the Good Times Summer Slot Tournament Series, participants are deemed to have consented to the use of their image and likeness in any and all media, whether now known or hereafter devised, at any time.

21. MCRS staff, vendors, and entertainers, as well as guests who are currently expelled from MCRS, are not eligible to participate in the tournament.
