



Official Rules

1. Participants must be 18 years or older and a Morongo Rewards member to participate. Morongo Rewards membership is fast, free, and easy. Register for Morongo Rewards membership at the Cashier's Cage.
2. **Money Klip™** allows Morongo Rewards members to load their players card with cash, and access these funds directly at a participating slot machine through use of their secure PIN.
3. To participate, Morongo Rewards members must first activate **Money Klip™** on their Morongo Rewards card by visiting a Player Services counter. A valid government-issued ID and Morongo Rewards card is required for activation.
4. During activation at Cashier's Cage, a one-time deposit of any nomination must be made to load the **Money Klip™** account. Once the player's **Money Klip™** account is activated, it can be funded by inserting bills in any participating slot machine while their Morongo Rewards card is carded in that machine.
5. Any accumulated credits will automatically be added to the player's **Money Klip™** account when their Morongo Rewards card is removed.
6. Funds in the **Money Klip™** account do not expire.
7. To play funds on their **Money Klip™**, players simply insert their card at the machine and enter their secure PIN. Then, click the money icon and define how much cash they wish to bring into the game from the **Money Klip™** account, and begin playing the slot machine.
8. To move the balance at the machine to their Morongo Rewards card, players simply remove their Morongo Rewards card from the machine after play, and any remaining balance is transferred back into their **Money Klip™** account.
9. To cash out fund from their **Money Klip™**, players simply insert their card at the machine and enter their secure PIN. Then, click the money icon and define how much cash they wish to bring into the game from the **Money Klip™** account, and hit the CASH OUT button to print the ticket. Tickets can be redeemed at any Ticket Redemption kiosk or at Player Services.
10. No cash substitutions will be permitted.
11. MCRS Poker, Video Roulette, Table Games, and Travel Center machines do not qualify for the program.
12. Morongo Casino Resort Spa ("MCRS") is not responsible for computer malfunctions resulting in the loss of cash.
13. A Morongo Rewards card and valid government issued photo ID are required to participate in the program.
14. MCRS is not responsible for any technical malfunctions, failures, or difficulties, printing errors, clerical, typographical or other errors within the offering or notification, or for any errors of any kind, whether human, mechanical, clerical, electronic, or technical in nature, or for the incorrect, inaccurate or failure to capture the appropriate information.
