

Promotion Rules

Swords & Shields Hot Seats – October 2022

1. The **Swords and Shields Hot Seats** will be held at 12:00pm – 6:00pm on Wednesdays & Thursdays in October; October 5 - 7, 2022. All Morongo Rewards members playing at Casino Morongo are eligible to participate in the promotion.
2. Participants must be 18 years or older and a Morongo Rewards member to participate. Morongo Rewards membership is fast, free, and easy. Register for a Morongo Rewards membership at the Morongo Rewards Desk, or online at www.morongocasinoresort.com
3. Guests will earn one (1) entry for every ten (10) points earned while playing with their Morongo rewards card at their favorite slot machine.
4. MCRS machines, Travel Center machines, and Table Games do not qualify to participate.
5. Beginning at 12:00pm, two (2) Morongo Rewards members will be randomly drawn every thirty minutes.
6. Guests must have a valid photo ID and Morongo Rewards card to be eligible to win. This process will continue until (2) winners has been located and identified.
7. After each participant has been drawn, the winners will be located on the casino floor where the winners will go head to head in a game of Swords & Shields (Tic, Tac, Toe).
8. Each player will alternate placing Swords (X's) and Shields (O's) on the board until either player has three in a row, horizontally, vertically, or diagonally. If a player is able to get three in a row then that player wins.
9. The winner will receive \$200 FSP and the loser will receive \$25 FSP as a consolation prize
10. If all squares are filled and neither player has made a complete row of Swords (X's) or Shields (O's), then the game is a draw
11. In the event of a tie, the players will play another round of Swords & Shields. If that results in a tie, both participants will split the prize and receive \$125 FSP.
12. Free Slot Play will be loaded to each contestant accounts within thirty (30) minutes and will expire within 24 hours.
