

Tailgate Fridays – September 2022

Promotion Rules

1. Participants must be 18 years of age or older and a Morongo Rewards member to participate. No purchase necessary. Morongo Rewards membership is fast, free and easy. Register for a Morongo Rewards membership at the Morongo Rewards Desk or at the Promotions Counter.
2. MCRS poker, Table Games, Travel Center machines, and Casino Morongo machines do not qualify for the promotion.
3. A Morongo Rewards card and valid government issued photo ID are required to participate in the promotion and to claim a prize. Any participant who cannot provide the required documents will forfeit the prize.
4. **Tailgate Fridays** will take place from 1:00pm- 8:00pm on Friday, September 2, 9, 16, 23 & 30, 2022 at the promotional stage, in the New Expansion area, located near Wahlburgers.
5. Morongo Rewards members playing Slots will receive one (1) ticketless entry for every one hundred (100) points. Entry earning is from 12:00am – 7:59pm on promotional dates.
6. Entries must be activated at least one hour prior to each drawing by swiping the Morongo Rewards card at a Morongo Rewards kiosk or by having an open rating during the activation period. Entries do not roll over and will expire after each weekly drawing.
7. Two (2) winners will be drawn each hour to win up to \$1,000 FSP.
8. The selected winner will have seven (7) minutes to identify themselves at the promotional area or their prize is forfeited and an alternate entry will be selected. Redraws will occur until all winners have been identified.
9. Guests may only win once per promotional day.
10. Once all participants have been identified at the stage each participant will compete in a beer Pong match.
11. Players must:
 - Upon arrival each guest will be assigned a team depending who arrives first
 - Guests must stand in their respected area behind the buckets at all time during the match
 - The Eye-to-Eye rule will determine which guests will go first. Both guests will each shoot one (1) ball at the same time. If both buckets are made the process will start over. However, if one guest makes the bucket and the other one does not then the guest who made the bucket will begin the match
 - Guests will each shoot two (2) balls during their turn. Each time a ball lands inside a bucket a bucket will be removed
 - Each guest will alternate turns
 - The “Balls Back” rule will apply if the guest makes both balls in during their turn. If the guest makes both shots, they will get to shoot again
 - The guest can only do an over hand throw; however, they may also bounce the ball from the floor to make it into the bucket
 - Guests will have seven (7) minutes to eliminate all of their opponents’ buckets. If time runs out the guest with the most buckets will win the grand prize of \$1,000 FSP. The runner-up will receive \$500 FSP
 - In case of a tie there will be a sudden death round. Each guest will take turns throwing one (1) ball until an opponent does not make the shot

12. The participant will have seven (7) minutes to eliminate all of their opponents' buckets. If time runs out the guest with the most buckets will win the Grand Prize of \$1,000 Free Slot Play ("FSP") and the second-place winner will receive a consolation prize of \$500 in Free Slot Play ("FSP").
13. Each participant will win a bonus in the form of FSP based on their card tier
Titanium = \$50 Gold = \$100 Black = \$125 Jade = \$150
14. The audience will have an opportunity to get in on the action. Morongo Rewards will also have a chance to receive an *Audience Participation Entry*. Any audience members can swipe their Morongo Rewards card to receive an Audience Participation Entry.
15. Audience Participation Winners simply report to a Promotions Representative when drawn to redeem their prize. Any unclaimed prizes will be forfeited.
16. Guests may win once per promotional day. Must be present to win.
